

3G Football Pitch Avlemore

I ask you to look at this application for the following reasons:

The land which HC propose to use was a now demolished birch wood and part of Seafleld Estate land designated for community use. The latest proposal will be gated and only available for pre booked use. This effectively means that the community at large will be unable to access the site.

The previous site was accessible to everyone whether it was football, or other games and kite flying.

3G pitches are basically for football. Other games eg hockey, shinty and rugby are unsultable because of the risk of damage to synthetic surface. Special footwear needs to be worn for football played on 3G pitch. Not really an option for anyone bar professional teams.

3G pitches are normally run as commercial facilities and charges of up to £50 per hour are levied for full pitch use. If this is the case in Aviemore, there will be very few able to afford to use what was a community facility and this surely should then become an application for change of use from community to commercial use - which is not part of historical agreement with Seafield Estate.

Plans published on Highland Council are not to scale as distance between boundary and No 12 Birch Road and the proposed pitch is only 4 metres.


This whole proposal is sited within a residential area. Lighting at the proposed height whether directed to the pitch or not will impact on properties for a long distance from the site. Noise levels from this type of facility will also impact on properties for some distance from the site.

Quality of life in the vicinity, already impaired by community school project will be made unbearable by additional noise and light pollution. Please also consider among surrounding properties are - The Green (Hanover Sheltered Housing). Kinveachy Gardens (Highland Council Sheltered Housing on perimeter of school site). Birch Road (majority of properties occupied by over 60s). Silverglades mainly holiday lets and some residential. Burnside Place, Burnside Avenue and Burnside Road which is high density housing.

3G pitches are normally sited in areas where there will be no impact on residential areas.

CNPA ultimately passed planning permission back to Highland Council for the Community School development with various provisions for wildlife corridor etc., No visible evidence of wildlife corridor as extra trees had to be felled (during nesting season) because Council misjudged area needed. School structure now resembles an alreraft hanger tall enough to house a jumbo jet, despite former restrictions on height. April, May and June saw the former birch wood become killing fields for ground nesting wildlife.

This development appears to have been taken for granted as I was told on the first week of contractors moving on to site that a synthetic pitch was part of the plan. It seems that planning permission has been very much taken for granted. There is much local anger about this.


Couldn't find the correct place to lodge a complaint...so if you could pass this on to the relevant person...who may be Marie Duncan that would be lovely please.

Having only just been officially "Neighbour Notified" of the latest proposal to the Primary School Plans, I apologise for the lateness of this correspondence.

Please accept these my comments on the latest alteration to the "Aviemore Primary School Planning Proposals" :-

"Once again 'Alterations & Additions' are being made to these plans without prior public discussion.

The idea of an Artificial Surface & Floodlighting here in Badenoch & Strathspey is totally out of place; field sports are not played here in the winter season due to the often frozen and/or snow covered state of the ground; lighting is therefore not called for.

During the 'Summer Season' there is plenty of light in the night sky & therefore no need for 'Artificial Lighting'.

Lastly but most importantly:-

Discussions & public meetings were held over several years regarding more than one school design & more than one architect; an agreement was reached with the Highland Council to cede the 'People of Aviemore's Recreation Area' to land for the construction of this Primary School, in exchange for a similar piece of land for similar usage within the wooded area of the whole site. This was to be arranged so that as much as possible of these woods should be preserved in their natural condition; this both for the wildlife & general environmental conditions of the surrounding residential area.

The piece of land being exchanged was not just a football pitch but general use common land where people would walk, run, fly kites or aeroplanes, exercise dogs, bairns practiced golf and successful Aviemore football teams have played here since 1934.

This ground is not part of the Primary School and should not be so considered."
