Section 6 Housing Policy H2 Development

#### Nethy Bridge Housing Development on H2 designated land

Road Unsuitable: A planning department condition placed on Goldcrest Homes prior to the development at Lynstock Park and Lettoch Road around 1999/2000included the insistance that Lettoch Road should remain single track with passing places. Any new development beyond the current boundary will require a wider/bigger road.

Sewage System: The sewage system was upgraded nearly 15 years ago to create additional capacity for 70 houses in the village. Since then at least 60 new houses have been built in the village leaving a surplus capacity for no more than 10 new houses. The proposed development will fully utilise that capacity and with the extra houses degrade the sewerage infrastructure.

Holiday Homes: The village does not need another 20 holiday homes. Over 60% of the houses in the village are holiday homes at more will just make the issues worse

Linear Developments: According to the previous local plan linear settlements were positively disliked and were to be discouraged. This development would be counter to that position as it would extend the village boundary by some 400/500 metres meaning that the boundary would be over a mile from the village centre.

Traffic Generation: With the boundary extended by 400/500 metres people would be more likely to use their cars to visit the village centre. This quiet road is currently used by tourists and locals for walking and cycling. Thus increasing the probability of accidents. Wildlife: The development land is on the nature corridor between the Abernethy forest and the river Nethy. Red squirrels, hares, deer, pine martins are regular users of the corridor. In addition, the endangered Oyster catcher nests on the land.
