"protect and enhance ancient semi-natural woodland as an important and irreplaceable resource, together with other native or long-established woods, hedgerows and individual trees with high nature conservation or landscape value"

and Para 216:

"Ancient semi-natural woodland is an irreplaceable resource and, along with other woodlands, hedgerows and individual trees, especially veteran trees of high nature conservation and landscape value, should be protected from adverse impacts resulting from development."

It is wholly unacceptable to have a lower standard of protection for Ancient Woodlands in the Cairngorms National Park than that afforded to such woodlands in the rest of Scotland.

The Spatial Strategy pays scant regard to the environmental damage that the proposed developments would cause if implemented.

Dualling of the A9 would separate and fragment wildlife populations on either side of the A9, yet there are no proposals for mitigation by green bridges. Instead of warning of the dangers that major roads bring in terms of increased pressure for unsuitable and unsustainable development, the LDP rubs its hands in anticipation of more housing and more business - in other words, more destruction of the special qualities for which the NP was established.

We were assured that the development of An Camas Mòr would relieve the development pressure on other settlements, particularly in Badenoch and Strathspey, yet the proposed rate of development in these other settlements shows no sign of slowing. Indeed, both the dualling of the A9 and the development of An Camas Mòr, if it ever goes ahead, look set to accelerate the rate of the transformation of Badenoch and Strathspey from scattered rural communities to suburban sprawl.

2. What is your comment on this section of the Plan?

The history of the NP's achievements to date suggest that the aspirations listed are delusional. That history includes a grossly excessive allowance for a market-led supply of large luxury houses, wholly unsuitable for meeting local, particularly first-time, needs. These houses have inevitably been sold largely as second/retirement or holiday homes, thus damaging communities and using up what land suitable for development was available within communities, whilst mainly benefiting large landowners and large house-builders. Thus, the new development allocations encroach increasingly onto land valuable for its environmental qualities, for amenity and for landscape to a large extent in disregard of the First Aim of the NP.

The warning sounded by Highland Regional Council in 1991 has still not been heard sufficiently by the NP: "concern is emerging about the rate and scale of change in established villages. Unsympathetic cramming and expansion of communities is eroding their character and setting, threatening to overwhelm facilities, or creating imbalance in the social structure."

1. A considerable reduction in the overall level of house-building.

2. An emphasis on building a far greater proportion of smaller houses (one or two bedrooms), suitable for first time buyers.

An Camas Mor

I regard the An Camas Mor proposal as a strategic mistake for the CNPA. Building a large community close to the core of a protected area is a recipe for continued major problems, which is why An Camas Mor, if continued, would have the distinction of being the only new town built in such a location in any national park. It would be distinguished by its inappropriate and damaging nature, a mistake of such a magnitude that every other national park has managed to avoid. That is not a matter for celebration. The assertion that An Camas Mor will be "sustainable" is unsupported on any rational basis, as well as being undefined.

The addition of 1500 houses and their attendant human population in the core of the national park, close to European Sites, will greatly increase pressure on those sites and the introduction of what will be seen as draconian restrictions on access to those sites in an attempt to mitigate the damage will simply lead to more conflict. Even supposing a new community of the size proposed for An Camas Mor were required, which I do not accept, it would simply be in the wrong place and would destroy semi-natural habitat to an unacceptable extent.
