



# Terms and Conditions: 'Best views of the Cairngorms National Park' survey

## Cairngorms National Park Authority Privacy Policy

## Prize Draw Terms and Conditions

1. The Prize Draw is open to people aged 18 and over who provide their contact details.
2. Employees of the Cairngorms National Park Authority, other project partners, or their family members, or anyone else connected with the Prize Draw may not enter the Prize Draw.
3. To enter the Prize Draw you must complete the Best Views of the Cairngorms National Park survey and submit your email address. No purchase is necessary. 4. Only one entry to the prize draw per person (although multiple views can be submitted). Entries on behalf of another person will not be accepted and joint submissions are not allowed.
5. The Cairngorms National Park Authority accepts no responsibility for entries that are incomplete or cannot be entered for any technical or other reason. Proof of submission of the entry is not proof of receipt.
6. The closing date of the Prize Draw is midnight on 4 March 2024. Entries received outside this time period will not be considered.

7. One winner will be chosen from a random draw of entries received in accordance with these Terms and Conditions. The draw will be performed by a random computer process. The draw will take place on 7 March 2024.
8. The winner will receive £100 in the form of a shopping voucher of their choice.
9. The winner will be notified by email by 8 March 2024 and must provide their choice of shopping voucher to claim the prize. Vouchers must be purchasable online with no additional booking fee. If a winner does not respond within 14 days of being notified, then the winner's prize will be forfeited and another winner will be selected in accordance with the process described above. If the winner rejects their prize or the entry is invalid or in breach of these Terms and Conditions, the winner's prize will be forfeited and another winner selected.
10. The prize is non-exchangeable and non-transferable.

The Cairngorms National Park Authority shall use and take care of any personal information you supply as described in the Privacy Statement below and in accordance with data protection legislation. By entering the Prize Draw, you agree to the collection, retention, use and distribution of your personal information in order to process and contact you about your Prize Draw entry.

The Cairngorms National Park Authority accepts no responsibility for any damage, loss, liabilities, injury or disappointment incurred or suffered by you as a result of entering the Prize Draw or accepting the prize. The Cairngorms National Park Authority further disclaim liability for any injury or damage to your or any other person's computer relating to or resulting from participation in or downloading any materials in connection with the Prize Draw.
